Violence Prevention and Intervention - A program which runs two domestic/sexual abuse shelters and provides domestic and sexual violence intervention and prevention services to individuals in the community. Trained advocates provide emotional support, safety planning, court advocacy and referrals to community resources.

Through these services, 2,893 individuals benefitted from services in fiscal year 2019.

4b (Code:) (Expenses \$ 1,014,254. including grants of \$ 519,211.) (Revenue \$ 0.)

Community Resources - A program to provide food support and other emergency services and resources for people in need as well as support individuals and families along their path to long-term self-sufficiency.

In fiscal year 2019, the network of five food shelves and two resource centers provided immediate aid and resources to 9,535 individuals to support them in their journey back to empowerment and long-term self-sufficiency.

School Success - We provide child care resources and services to promote quality child care programs that prepare children for school. We work in schools to support at-risk students and families with stabilizing resources and family learning plans to ensure each student has the best opportunity for academic success.

In fiscal year 2019 the programs engaged 3,511 parents and students from 32 schools.
